THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument – Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009², and in particular Article 23(2) thereof,

Whereas:

- (1) On 16 December 2021 the Commission adopted Implementing Decision C(2021) 9283 on the financing of the annual action plan in favour of the United Republic of Tanzania for 2021.
- (2) The amendment aims to increase the financing of the Gender Transformative Action in Tanzania: “Breaking the Glass Ceiling” under the annual action plan by EUR 20 000 000. While Tanzania has achieved gender parity in primary education, including a re-entry policy for pregnant girls, challenges still hinder the education of adolescent mothers, highlighting the need for continued investment and policy reforms to support girls' education in the country.
- (3) The specific objectives of the programme and results as initially established will remain unchanged, as the programme already integrated education-related interventions that will now be reinforced and the implementation period will be extended by 24 months.
- (4) Commission Decision C(2021) 9283 should therefore be amended accordingly.
- (5) This Decision is in accordance with the opinion of the NDICI Committee established under Article 45 of Regulation (EU) 2021/947,

HAS DECIDED AS FOLLOWS:

Sole Article

Implementing Decision C(2021) 9283 of 16 December 2021 is amended as follows:

(1) Article 2 is replaced by the following:

‘The maximum Union contribution for the implementation of the action plan for 2021 is set at EUR 200 000 000, and shall be financed from the appropriations entered in the budget line 14.020121 of the general budget of the Union.

The appropriations provided for in the first paragraph may also cover interest due for late payment.’

(2) Annex 2 to Implementing Decision C(2021) 9283 is replaced by the text in the Annex to this Decision.
