amending Commission Implementing Decision C(2023)6877 of 09.10.2023 on the financing of the support measure in favour of the Republic of Seychelles for 2023

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2024/2509 of the European Parliament and of the Council of 23 September 2024 on the financial rules applicable to the general budget of the Union¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument – Global Europe, amending and repealing Commission Implementing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009², and in particular Article 24(2) thereof,

Whereas:

- (1) By its Decision C(2023) 6877 of 09.10.2023 the Commission has adopted the financing of the support measure in favour of the Republic of Seychelles for 2023.
- (2) The Cooperation Facility aims to support the Republic of Seychelles in the priority areas (i) Environment protection and climate change adaptation and resilience, (ii) Good Governance. In order to facilitate support to the different actions and institutions most suited to deliver efficient assistance, the implementation modality set out in the Annex needs to be expanded from direct management (procurement) to direct management (grants) and indirect management.
- (3) Therefore, Commission Implementing Decision C(2023)6877 of 09.10.2023 should be amended accordingly.
- (4) The amendments provided for in this Decision do not fall within the categories of amendments for which the prior opinion of the Committee is required. The Committee established under Article 45 of Regulation (EU) 2021/947 should be informed of this amending decision within one month following its adoption,

HAS DECIDED AS FOLLOWS:

Sole Article

- (1) Commission Implementing Decision C(2023) 6877 is amended as follows:

‘Article 4

Methods of implementation and entrusted entities or persons

The implementation of the actions carried out by way of indirect management, as set out in the Annex, may be entrusted to the entities or persons referred to or selected in accordance with the criteria laid down in point 4.3.3 of the Annex.’

- (2) The Annex to the Commission Implementing Decision C(2023)6877 of 09.10.2023 is replaced by the Annex to this Decision.
