## **amending Implementing Decision C(2022)5681 on the financing of the annual action plan in favour of the Republic of Malawi for 2022**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012<sup>1</sup>, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument – Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009<sup>2</sup>, and in particular Article 23(1) thereof,

Whereas:

- (1) By its Decision C(2022)5681<sup>3</sup> the Commission has adopted the annual action plan in favour of the Republic of Malawi for 2022.
- (2) The implementation modalities set out in the Financing Agreement were affected by recent modifications to INTPA's procedures as well as by the phasing out of the National Authorised Officer following the expiry of the Cotonou Agreement. It is appropriate to revise the implementation modalities reflecting the current context while reinforcing collaboration with the Government of Malawi.
- (3) Therefore, Commission Decision C(2022)5681 should be amended accordingly.
- (4) The amendment provided for in this Decision does not fall within the categories of amendments for which the NDICI-Global Europe Committee established under Article 45 of Regulation (EU) 2021/947 should be informed of within one month following its adoption,
