# COMMISSION DECISION

of 9.2.2022

## amending Commission Decision C(2020) 611 final of 30.1.2020 on the financing of the individual measure in favour of the United Republic of Tanzania

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EU) 2015/322 of 2 March 2015 on the implementation of the 11<sup>th</sup> European Development Fund<sup>1</sup>, and in particular Article 9(1) and (4) thereof,

Having regard to Council Regulation (EU) 2018/1877 of 26 November 2018 on the financial regulation applicable to the 11<sup>th</sup> European Development Fund, and repealing Regulation (EU) 2015/323<sup>2</sup>, and in particular Article 24 thereof,

Whereas:

- (1) By Decision C(2020) 611<sup>3</sup>, the Commission has adopted the individual measure in favour of the United Republic of Tanzania.
- (2) The current amendment to Decision C(2020) 611 aims at introducing the option to operate under direct management mode with a dedicated budget allocation for procurement, in order to allow the use of a framework contract (for amounts up to EUR 1 000 000).
- (3) Therefore, Decision C(2020) 611 should be amended accordingly.
- (4) The amendment provided for in this Decision does not fall within the categories of amendments for which the prior opinion of the European Development Fund ('EDF') Committee is required. The EDF Committee established under Article 8 of the Internal Agreement should be informed of this amending decision within one month following its adoption.

HAS DECIDED AS FOLLOWS:

### *Sole Article*

Decision C(2020) 611 is amended as follows:

- (1) In Article 3, the following paragraph is added:

“A part of the action shall be carried out in direct management through procurement as laid down in point 5.4.2 of the Annex.”;

- (2) The Annex to the Commission Decision C(2020)611 is integrated by the Annex to this Decision.
