## amending Commission Implementing Decision C(2021) 9286 of 16.12.2021 on the financing of the multiannual action plan in favour of Thailand for 2021-2023

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union (TFEU),

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012<sup>1</sup>, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument – Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009<sup>2</sup>, and in particular Article 23 (1) and (2),

Whereas:

- (1) By its Decision C(2021) 9286 of 16.12.2021 the Commission has adopted the Commission Implementing Decision on the financing of the multiannual action plan in favour of Thailand for 2021-2023. The Commission should take note of the following non-substantial changes that were carried out by the responsible authorising officer under the flexibility provision of Article 4 of the Decision: the global budgetary envelope for procurement was decreased by 20% of the total EU contribution to the financing decision and the amount for indirect management with pillar-assessed organisations was increased correspondingly.
- (2) Additional re-allocations of EUR 2 000 000 within the global budgetary envelope are required in order to further increase the amount for indirect management with pillar-assessed organisations. The amount for grants will be re-allocated entirely to indirect management. As a result, the change to the global envelope for grants will go beyond the flexibility provision.
- (3) Other minor adjustments are to be done in reference to the context, problem analysis and the communication related issues in line with the Cooperation Facility Guidelines 2023.
- (4) The amendment provided for in this Decision does not fall within the categories of amendments for which the prior opinion of the Committee is required. The Committee established under Article 45 of Regulation (EU) 2021/947 should be informed of this amending decision within one month following its adoption.
