THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument – Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009¹, and in particular Article 23(1) and (2) and Article 25(2)(d) thereof,

Having regard to Regulation (EU, Euratom) 2024/2509 of the European Parliament and of the Council of 23 September 2024 on the financial rules applicable to the general budget of the Union², and in particular Article 110 thereof,

Whereas:

- (1) By its Decision C(2023)7720 of 9.11.2023 the Commission has adopted the multiannual action plan in favour of the Americas and the Caribbean for 2023 part II and 2024 part I.
- (2) The purpose of this amendment to the Action Document Latin America and Caribbean Investment Facility LACIF (Annex I – ACT-61002) is to top-up the Decision by the amount of EUR 56 790 000. As the increase is above 20% / EUR 10 million of the total amount of the initial financing decision it is therefore considered as a substantial rider and requires a new Commission Decision. The top-up only changes the Annex I in terms of budget, no changes are made to the policy objectives.
- (3) Therefore, Commission Decision C(2023)7720 of 9.11.2023 should be amended accordingly.
- (4) The envisaged assistance is to comply with the conditions and procedures set out by the restrictive measures adopted pursuant to Article 215 TFEU³.
- (5) This amending decision provided for in this Decision is in accordance with the opinion of the Committee established under Article 45 of Regulation (EU) 2021/947,

HAS DECIDED AS FOLLOWS:

Sole Article

Commission Implementing Decision C(2023) 7720 of 9.11.2023 is amended as follows:

(1) Article 2 is replaced by the following paragraph:

“The maximum Union contribution for the implementation of the action plan for 2023 and 2024 is set at EUR 171 010 000 (EUR 20 000 000 for the Regional Cooperation Facility and EUR 151 010 000 for LACIF), and shall be financed from the appropriations entered in the following line of the general budget of the Union:

- (1) General budget of the Union for 2023: budget line 14.020140-C1-INTPA: EUR 20 000 000;
- (2) General budget of the Union for 2023: budget line 14.020140-C7-INTPA: EUR 19 210 000;
- (3) General budget of the Union for 2023: budget line 14.020141-C7-INTPA: EUR 40 000 000;
- (4) General budget of the Union for 2024: budget line 14.020140-C1-INTPA: EUR 74 750 000;
- (5) General budget of the Union for 2024: budget line 14.020141-C1-INTPA: EUR 17 050 000.

The appropriations provided for in the first paragraph may also cover interest due for late payment.”

- (2) The Annex 1 to the Commission Implementing Decision C(2023) 7720 of 9.11.2023 is replaced by the Annex to this Decision.
