5.2 Indicative implementation period

2) This section is replaced to read as follows:

‘The indicative operational implementation period of this action, during which the activities described in section 4 will be carried out and the corresponding contracts and agreements implemented, is 96 months from the date of the entry into force of the financing agreement.

Extensions of the implementation period may be agreed by the Commission’s responsible authorising officer by amending this Decision and the relevant contracts and agreements. ‘

5.4 Implementation modalities

3) A new section is added to read as follows:

‘5.4.2. Grants: (direct management)

a) Purpose of the grant(s):

Result 2 – activities to achieve output 2

The global objective of this call for proposals is:

To contribute to the achievement of the national development goals for Education and Life skills, Water Sanitation and Hygiene, Management of Natural Resources.

The specific objective of this call for proposals is:

To improve the participation of Civil Society Organisations in the design, implementation and monitoring of relevant public policies and programmes in the education, Life skills, Water/Sanitation/Hygiene and Community-Based Natural Resource Management (CBNRM) sectors.

b) Type of applicants targeted:

Civil Society Organisations mainly working in the Education and Life Skills, Water, Sanitation and Hygiene and CBNRM sectors.’

‘As part of its prerogative of budget implementation and to safeguard the financial interests of the Union, the Commission may participate in the above governance structures set up for governing the implementation of the action.’
