1 INTRODUCTION

The Pakistan Multi-Donor Trust Fund (MDTF) for Khyber Pakhtunkhwa (KP), Federally Administered Tribal Areas (FATA) and Balochistan was established in August 2010. It is one of the key instruments to support the reconstruction, rehabilitation, reforms and other interventions needed to build peace and create the conditions for sustainable development in the aftermath of the 2009 crisis – together with reducing the potential for the escalation or resumption of conflict in these regions. The MDTF is administered by the World Bank and supported by the following donors - Australia, Denmark, European Union, Finland, Germany, Italy, Netherlands, Switzerland, Sweden, Turkey, UK, and the USA.

The efficiency and effectiveness of the MDTF is evaluated on an annual basis. The primary aim of the Annual Reviews (AR) is to evaluate the progress made by MDTF over the past 12 months. The last five joint annual reviews were helpful in setting strategic direction of the MDTF, supported in developing a comprehensive results and reporting framework aligned with the PCNA indicators and the work that is being done to develop strategic communication. It also served as an engagement tool with the WB as administrator of the fund.

2 ASSIGNMENT OBJECTIVES

2.1 Global Objectives

This assignment related to the Annual Reviews six and seven during 2017 and 2018 respectively. EU contributed the services of a Monitoring and Evaluation Expert to the annual review team consisting of experts provided by different donors. This assignment had as objective to contribute to the Annual Review of the MDTF 2016 and 2017.

2.2 Specific Objectives

Under the overall coordination of the Team Leader and in close cooperation with the other members of the AR evaluation team, the expert was expected to contribute to the overall review conducted by a team of experts specialised in complementary fields and provide quality inputs related to his expertise in the part "Monitoring and evaluation – results" and other areas as assigned. Key work streams included:

- How effective are the mechanisms in place for monitoring and evaluation and is the data required adequate, available in the format required and sufficiently robust.
- Quality assure the output data available for the review and provide recommendations, as appropriate.
- Analyse if the programme data sufficiently reflects its focus on poor and underserved areas, women, girls and children, and the requirements of the Gender Equality Act?

2.3 Requested Services

The expert was expected to participate in the overall annual review 2016 and 2017 as part of the Core team and participate in the review the programme against the 2016 and 2017 Annual Review and MDTF results framework and progress for Round II of the MDTF and provide specifically the following services:

- Review the existing arrangements of M&E at portfolio and project level
- Provide a commentary on M&E products, reports, analysis
- Review the performance of third party monitors and identify issues that need to be raised with the TTLs of the MDTF Secretariat
- Review how M&E processes are inclusive and feedback mechanisms are reaching out to vulnerable groups, especially women and girls
- Follow-up M&E recommendations of the last annual review and state the progress against those recommendations
- Finally provide concrete recommendations
