# COMMISSION IMPLEMENTING DECISION

of 12.12.2022

## on the financing of the annual action plan in favour of Cuba for 2022

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012<sup>1</sup>, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument – Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009<sup>2</sup>, and in particular Article 23(2) thereof,

Whereas:

- (1) In order to ensure the implementation of ‘Support to New Economic Actors - Modernisation of the Economy’, ‘Support to the Public Administration - Modernisation of the Economy’ and ‘Support to Cuban biotechnological industry and investments towards Global Public Goods’, it is necessary to adopt an annual financing decision, which constitutes the annual work programme, for 2022. Article 110 of Regulation (EU, Euratom) 2018/1046 (‘the Financial Regulation’) establishes detailed rules on financing decisions.
- (2) The envisaged assistance is to comply with the conditions and procedures set out by the restrictive measures adopted pursuant to Article 215 TFEU<sup>3</sup>.
- (3) The Commission has adopted the National Multiannual Indicative Programme for Cuba for the period 2021-2027<sup>4</sup>, which sets out the following priorities: ‘Ecological transition: Sustainable municipalities’; and ‘Modernising the economy, maximising the potential of all economic actors in key sectors’.
- (4) The objective pursued by the annual action plan to be financed under the Regulation (EU) 2021/947 NDICI-Global Europe, geographic programme ‘Americas and the Caribbean’ is to contribute to the modernisation of the Cuban economy.

- (5) The action entitled ‘Support to New Economic Actors - Modernisation of the Economy’ aims to contribute to the well-being of the Cuban people by supporting a dynamic economy and specifically the recently regulated and privately owned micro, small and medium-sized enterprises (MSMEs). The action entitled ‘Support to the Public Administration - Modernisation of the Economy’ aims to contribute to the digital transition of the Cuban public administration. The action entitled ‘Support to Cuban biotechnological industry and investments towards Global Public Goods’ aims to strengthen capacities for the development, production, approval and control of relevant, safe and effective biotechnological products.
- (6) Pursuant to Article 26(1) of Regulation (EU) 2021/947 indirect management is to be used for the implementation of the action.
- (7) The Commission is to ensure a level of protection of the financial interests of the Union with regards to entities and persons entrusted with the implementation of Union funds by indirect management as provided for in Article 154(3) of the Financial Regulation.
- To this end, such entities and persons are to be subject to an assessment of their systems and procedures in accordance with Article 154(4) of the Financial Regulation<sup>5</sup> and, if necessary, to appropriate supervisory measures in accordance with Article 154(5) thereof before a contribution agreement can be signed.
- (8) It is necessary to allow for the payment of interest due for late payment on the basis of Article 116(5) of the Financial Regulation.
- (9) In order to allow for flexibility in the implementation of the action plan, it is appropriate to allow changes which should not be considered substantial for the purposes of Article 110(5) of the Financial Regulation.
- (10) The action plan provided for in this Decision is in accordance with the opinion of the Committee established under Article 45 of Regulation (EU) 2021/947.

HAS DECIDED AS FOLLOWS:

*Article 1*  
*The action plan*

The annual financing decision, constituting the annual action plan for the implementation of the annual action plan in favour of Cuba for 2022, as set out in the Annexes, is adopted.

The action plan shall include the following actions:

- (a) ‘Support to New Economic Actors - Modernisation of the Economy’ set out in Annex 1;
- (b) ‘Support to the Public Administration - Modernisation of the Economy’ set out in Annex 2;
- (c) ‘Support to Cuban biotechnological industry and investments towards Global Public Goods’ set out in Annex 3.

*Article 2*  
*Union contribution*

The maximum Union contribution for the implementation of the action plan for 2022 is set at EUR 31 000 000, and shall be financed from the appropriations entered in the following line of the general budget of the Union:

- budget line BGUE-B2022-14.020141: EUR 31 000 000;

The appropriations provided for in the first paragraph may also cover interest due for late payment.

*Article 3*  
*Methods of implementation and entrusted entities or persons*

The implementation of the actions carried out by way of indirect management, as set out in the Annexes, may be entrusted to the entities or persons referred to or selected in accordance with the criteria laid down in point 4.3.1 of the Annexes.

*Article 4*  
*Flexibility clause*

Increases or decreases of up to EUR 10 million and not exceeding 20% of the contribution set in the first paragraph of Article 2, or cumulated changes<sup>6</sup> to the allocations of specific actions not exceeding 20% of that contribution, as well as extensions of the implementation period shall not be considered substantial for the purposes of Article 110(5) of the Financial Regulation, provided that these changes do not significantly affect the nature and objectives of the actions.

The authorising officer responsible may apply the changes referred to in the first paragraph. Those changes shall be applied in accordance with the principles of sound financial management and proportionality.
