THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument – Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009¹, and in particular Article 23(2) and Article 25(2)(d) thereof,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012², and in particular Article 110 thereof,

Whereas:

- (1) By its Decision C(2016)8567 of 13.12.2016 the Commission has adopted the Annual Action Programme 2016 part 2 and 2017 part 1 in favour of Bangladesh.
- (2) United Kingdom's Foreign, Commonwealth & Development Office (FCDO) has withdrawn its co-financing for the action component 'Pathways to Prosperity for Extremely Poor People (PPEPP)' implemented by FCDO in Indirect Management. Instead, a new delivery method under Direct Management (grants) will be introduced for the EU contribution terminating the Delegation Agreement with FCDO. In addition, operational implementation period is extended until 31/03/2026.
- (3) Therefore, Commission Decision C(2016)8567 of 13.12.2016 should be amended accordingly.
- (4) The amendments provided for in this Decision do not fall within the categories of amendments for which the prior opinion of the Committee is required. The Committee established under Article 45 of Regulation (EU) 2021/947 should be informed of this amending decision within one month following its adoption.
