on adopting a Multiannual Indicative Programme for the external dimension of the ERASMUS+ Programme for the period 2021-2027

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation EU No 2021/947 of the European Parliament and of the Council establishing the Neighbourhood, Development and International Cooperation Instrument – Global Europe¹ (NDICI), and in particular Article 13 (6) thereof,

Whereas:

- (1) Regulation EU No 2021/947 (NDICI) Article 13 (6) provides that the NDICI shall contribute to actions established under Regulation (EU) No. 2021/817 (Erasmus+). A single programming document shall be drawn up from this Regulation for seven years, including funds from the IPA III Regulation. Regulation (EU) No 2021/817 (Erasmus+) shall apply to the use of these funds.
- (2) In accordance with Article 9, paragraph 4, second subparagraph of the Council Decision (EU) 427/2010 of 26 July 2010 establishing the organisation and functioning of the European External Action Service (EEAS)², the present geographic programme has been prepared jointly by EEAS and the appropriate Commission services under the guidance of the High Representative of the Union for Foreign Affairs and Security Policy/Vice-President of the Commission and presented to the College of Commissioners in agreement with the Commissioner responsible for International Partnerships and the Commissioner responsible for European Neighbourhood Policy. The ERASMUS+ Multiannual indicative programme for the period 2021-2027 should be adopted by the Commission on behalf of the European Union.
- (3) The measure provided for in this Decision is in accordance with the opinion of the NDICI Committee.

HAS DECIDED AS FOLLOWS:

Sole Article

The ERASMUS+ Multiannual indicative programme for the period from 2021 to 2027 is hereby adopted on behalf of the European Union. The Multiannual indicative programme is annexed to the present Decision.

The Member of the Commission responsible for international partnerships, or the person designated by her for this purpose, is authorised to sign the Multiannual indicative programme on behalf of the European Union.

The funding corresponding to the Instrument of Pre-accession III (IPA III) in this multiannual indicative programme is subject to the entry into force of the IPA III Regulation without

significant modifications, and of the subsequent adoption of the necessary implementing acts by the Commission in accordance with the procedure provided for by the applicable basic act.
